INTRODUCTION

There have been several high-profile vaccine scandals that have undermined public faith in vaccines. In 1955, more than 200,000 children were given a defective polio vaccine with live virus. Within a month of the first vaccination, paralysis was reported. After investigation, it was learned that ten children died, two hundred were paralyzed, and that there were 40,000 cases of polio. It is known as the Cutter Incident, named after the laboratory in California to which the tragedy and scandal were attributed. It was later learned that the polio vaccine, itself, was contaminated with a monkey virus known as simian virus SV40. It is the consequences of this fundamental contamination that made Dr. Judy Mikovits both famous and infamous. (Her story will be told below.) A generation later, in 1976, Guillain-Barré Syndrome (GBS) was associated with the vaccines for swine flu. In 2003, it was concluded that those who had taken the swine flu vaccine had an increased risk of developing GBS. Fifty-three deaths followed and now there are many more vaccinated individuals who suffer with GBS. About a generation later, in the late 1990s, a Hepatitis B vaccine was linked to the development of Multiple Sclerosis, a neurologic disease. Still more tragedy followed subsequent vaccination drives for influenza type B, H1N1, and narcolepsy (which all led to more cases of GBS). The 2013 recall of Gardasil, supposed to treat human papilloma virus did not alleviate concerns, but instead, enhanced them.1 And while the vaccine business rolls on, surviving suffering individuals are left to their families for care. In 2005, President Bush asked Congress to pass liability protection for vaccine makers so that they could not be sued as punishment or accountability for their sloppy production lines or mistaken science that resulted in human suffering. The idea proffered by some doctors that these were mistakes of science that must be tolerated for science to advance² is roundly rejected by the kernel of families directly negatively affected by those medical/pharmaceutical mistakes and their growing global audience.

Robert Kennedy, Jr. and his Children's Health Defense; **Del Bigtree** and his regular internet TV show, The Highwire; **Louis Farrakhan** and his organization, The Nation of Islam; and the millions of parents of vaccine-injured children who were misled by all of

the relevant governmental authorities,(the CDC, FDA, HHS, and others) to take a vaccine that harmed rather than helped, Every one of these parents and their children has an ever-growing network of family, friends, coworkers, and more. Their numbers and their united voices were finally heard when the documentary, VAXXED and its sequel, VAXXED II were released. No longer could the government blame the parents of vaccine-injured children. Ultimately, it became very clear that the health authorities in the U.S. had failed to protect the health of a huge number of U.S. families. This community formed the nucleus of a sub-culture in the U.S. who would work diligently to defy and expose any politician issuing any vaccination mandate and any health professional administering COVID-19 vaccines. Thus, the "pump" was primed, as it were, for the creation of a community of *refuseniks* who have exposed the U.S. government as a profiteer center for health care professionals who seem to have, long ago, forgotten their Hippocratic Oath. Even worse, they have done harm to others for personal profit. Following, is only a very small part of the story of true heroes and heroines whose work today continues to expose the unthinkable to a disbelieving world.

HEROES AND HEROINES OF THE "TRUTH ABOUT HEALTH, SARS-COV-2, AND COVID-19 MOVEMENT"

Many questions have been raised by parents of children adversely affected by U.S. vaccine policy that mandates certain vaccines for children and young adults by age. Between birth and the age of eleven years old, the typical U.S. child has had almost 35 different vaccination shots, according to the Cleveland Clinic.³ CDC whistleblower **William Thompson** shook the entire pro-vaccine establishment when he was secretly recorded, without his knowledge, admitting that CDC fudged the numbers on its studies,

particularly in reference to African American male "autism-like" side effects after administration of the MMR vaccine. Incredibly, the likelihood of autism-like effects experienced by African-American male MMR vaccine recipients was 340% higher than for non-African-American male MMR vaccine recipients.⁴ In fact, he states that the CDC chose to suppress the information and that this decision stood unaltered for at least a decade. Meaning that U.S. children were knowingly exposed to autism-like side effects by the CDC instead of being true to the data and taking the necessary steps to protect the children of the U.S. He also adds that "Big Pharma" (the pharmaceutical industry of the U.S.) pretty much has the medical scientific community under control and is successfully able to isolate individual scientists who might disagree with unethical, and indeed, deadly CDC practices. William Thompson, who admitted to committing acts of scientific fraud, still works at the CDC under whistleblower protection. His admission of CDC organized wrongdoing that overwhelmingly adversely affected young African-American males receiving its Mumps-Measles, Rubella vaccine was a modern-day low point in confidencebuilding for the CDC, whose predecessor organization, the U.S. Public Health Service, was responsible for the shameful **Tuskegee Study** that misled African-American men into believing that they were being treated for syphilis, when, in actuality, they were not being treated, although a treatment (penicillin) existed, but were instead being watched for the progression of the disease. The project began in 1932 and continued until a newspaper article about the study was published in 1972. The program was ended in 1972, and "on May 16, 1997, President Bill Clinton issued a formal Presidential Apology for the study."5

Judy Mikovits, Ph.D. was arrested and sent to prison by U.S. authorities currently highlighted favorably in the SARS-CoV-2/COVID-19 ongoing saga: mainly Dr. Tony Fauci, head of the U.S. National Institute of Allergy and Infectious Disease. In her 2014 book, *Plague of Corruption*, she alleges that retroviruses in medical research carry special dangers that continue unabated because of corruption by special interests in medical research funded by U.S. taxpayers. Unlike William Thompson at the CDC, Mikovits refused to alter the data of the science underpinning the entire vaccine industry in the U.S. and the rest of the world, and so, she was punished for her decision to blow the

whistle on, rather than suppress, her findings. She says that her entire life, since she was ten years old, she has wanted to cure cancer and other chronic diseases. But, her ordeal fighting Anthony Fauci and others, was costly in that she lost her reputation for impeccable science and integrity and her ability to pursue her passion. Dr. Fauci fought Judy Mikovits after her discovery of the retrovirus XMRV which underlies all vaccines produced by U.S. corporations, a part of Big Pharma. According to Mikovits, there are only two other retroviruses that affect humans: Human T-Cell Leukemia virus and HIV; Mikovits asserts that the then-newly-discovered XMRV retrovirus is also present in autistic children. On a 2009 public television news show, Nevada Newsmakers, with Sam Shad, Mikovits goes on to say, "This might even explain why vaccines lead to autism in some." The moment that Mikovits mentioned the possibility of vaccines being linked, even informally, to autism was the beginning of the end of Mikovits's career in science. She went from being called one of the most accomplished scientists of her generation for exposing that the use of animal and human fetal tissues in vaccines was unleashing a flood of chronic diseases; to being arrested, put under a five-year gag order, and she sat in prison with no charge, forced to declare bankruptcy. She says that in 1999, she was working in U.S.Army Medical Research Institute of Infectious Diseases (USAMRID) at Fort Detrick and her job was to teach ebola virus how to infect human cells without killing those cells. When asked about the ebola death toll and her culpability in human suffering, the talkative Ph.D. becomes mute. Mikovits maintains that the U.S. has been injecting animal viruses, by way of monkey kidney cells used in the polio vaccine, into humans for more than thirty years. This resulted in an explosion of chronic diseases in humans. She states that today's U.S. biolabs produce race- and gender-specific engineered viruses. Mikovits wrote Plague, about her experience in jail, in 2014 after her gag order ended; in 2020, she wrote *Plague of Corruption* in which she calls the names of all the Deep State medical actors, like Fauci, who are part of the corruption of medical care in the U.S. and throughout the world. In 2021, Mikovits and her co-authors wrote Ending Plague: A Scholar's Obligation In An Age of Corruption.

WHEN CHINA SNEEZES: From the Coronavirus Lockdown to the Global Politico- Economic Crisis is a book edited by this author, **Cynthia McKinney**,⁶ that was the first book on the market published in English to explore the politics and the economics of SARS-CoV-2. Veteran biological weapons investigator, **Jeff J. Brown**, author of Chapter One, tackles the problems associated with a U.S. patent regime that rewards certain

favored private actors for the results of publicly funded research projects. Poignantly, Chapter One exposes that the United States operates or funds hundreds of biolabs all over the world. Chapter Two attacks the demonization of China that accompanied the global lockdowns; Chapters Three and Four were written by anonymous actual residents of China who experienced the Lockdown. Chapters Five through Eight tackled the Economic Impact of the global phenomenon that the world saw unfolding. Chapters Nine through Eleven look at a world seemingly under attack from the deployment of a biological weapon. Was such a scenario possible? If so, who could think the unthinkable? Investigative journalist Whitney Webb takes on the Pentagon and its research into coronaviruses; Chapter Ten examines biological warfare as yet another form of economic warfare; Chapter Eleven explores the possibility of a virus being developed that actually targets certain populations or even individuals. In other words, have the biological sciences developed so far that they could be used by persons interested in carrying out a genocide? Chapters Twelve through Fourteen make the case that, while biological warfare might seem impossible or even inconceivable, a dystopian post-COVID-19 world that benefits the current ruling class or that creates an entirely new one is, indeed, possible. Contributors to this massive effort centered on the truth about the owners and purveyors of today's biological sciences and their possible motives and the vision for the future of all of us that these evil characters harbor. In addition to those already mentioned, the contributors to this book are: Larry Romanoff, Jack Rasmus, Michael Hudson, Peter Koenig, William Robinson, Whitney Webb, Claudio Peretti, Gary Barnett, Helen Buyniski, and Alfred de Zayas.

Dr. X, M.D. is an anonymous medical doctor who became transformed from just a medical doctor to a medical activist. Dr. X, M.D. became a medical activist in order to help get the message out that COVID-19, like HIV, was a disease accompanied by a political agenda. Highly respected in his own right, Dr. X, M.D. began a website⁷ to alert the public to the dangers of the virus, the spike protein, and the prescribed cure for the disease, the mRNA vaccines from Pfizer and Moderna. Dr. X, M.D. proposed alternative treatments based on the extant medical literature at the time and continuously updates the website as new research produces new options for those who did as well as for those who did not take the COVID vaccines. Dr. X, M.D. readily shares research with other medical doctors and others in the health professions; Dr. X, M.D. also helps medical professionals find their advocacy voice, so that more and more health professionals can not only know the truth about what has happened to humankind, but also so that the

courageous individuals in the field are perfectly armed to go into the public arena and share their knowledge with the innocent public. After investigating the nature of the spike protein, Dr. X, M.D. came to the conclusion that the biological weapon in SARS-CoV-2 is the spike protein. Through further research, Dr. X, M.D. discovered the racial specificity of the spike protein,8 affecting only certain populations subgroups whose bodies produced ACE2,9 FURIN,10 and/or TMPRSS2, proteins that are not equally distributed throughout the human population. While Dr. X, M.D. clearly hears the warning and Final Call of Dr. Vanden Bossche (see below) that the danger humanity faces is that innate immunity may be wiped out by COVID-19 vaccines, Dr. X, M.D. clearly understands that Traditional Chinese Medicine and other herbal medicines might be able to help even those who chose or otherwise felt pressured enough to take the COVID-19 vaccinations. Dr. X, M.D. also regularly updates the website with interesting interviews and news articles from mainstream¹¹ and alternative media and science outlets.¹² Further, Dr. X, M.D. maintains that it is important to expose the truth to government and important organizational elected officers by writing and encouraging others to write letters to and otherwise communicate public concerns to persons of positional authority; and, if they

fail to act on this shared knowledge, then lawsuits or other more aggressive actions are in order to remove these persons from their positions.¹³

Geert Vanden Bossche, D.V.M., Ph.D. is a Doctor of Veterinary Medicine and a Ph.D in virology. He is a certified expert in microbiology and in infectious diseases and has spent his entire career working in the field of human vaccinology. To date, he is the most prominent vaccinologist to discuss the problems encountered when vaccines do not stop transmission and are administered during a pandemic. His contention is that enormous pressure is applied to the virus so that it will create mutations that are more and more lethal. He believes that human interventions in the COVID-19 pandemic are currently driving "immune escape," that is increased infectiousness of more variants. He believes that mass vaccination as a prophylaxis is a "colossal blunder." ¹⁴ He predicts a tsunami of morbidity and mortality. In May 2022, he issued his final call: he contends that the mass vaccination process is destroying the innate immunity system, "the first line of immune defense," that humans have at birth. Mass vaccination is completely suppressing the innate immune system for those who have taken a COVID-19 vaccine on a permanent basis. He labels the acquired antibodies from vaccination completely worthless due to variants that mass vaccination causes. Mass vaccination of children denies them an innate immune system. In his final warning, his final call, Vanden Bossche says that the pandemic is anything but over. He says that the virus has become resistant to the antibodies produced by the vaccines. The vaccinated, then, are more susceptible to the newer circulating variants. We have never seen this phenomenon before. The virus is not being eliminated and the vaccinations are producing increased infectiousness (for vaccinees) by way of mutations. The common denominator that is the virus itself and the environment created in the body of those who took the vaccinations. This is why the Omicron variant has heightened infectiousness within the vaccinated population. He believes that it is only a matter of time, a few months, before we will see a variant that is both highly infectious—even more infectious than Omicron—AND highly lethal. Of course, according to Dr. Vanden Bossche, those who took the COVID vaccination, who voluntarily chose to allow Pfizer or Moderna to suppress their innate immune system, are

most at risk Finally, Dr. Vanden Bossche recommends a human intervention on the scale of the mass vaccination intervention that includes mass distribution of antivirals in a massive prophylaxis campaign (like massive distribution of ivermectin or hydroxychloroquine) in order to stop the variants. This mass distribution of antivirals should continue until the "infectious pressure" is alleviated. He concludes that Africa will win because its population is not highly vaccinated.

Dr. Lee Merritt, who calls herself a "Medical Rebel" on her website, 15 takes on professional medical orthodoxy when it comes to SARS-CoV-2 and COVID-19. She questions whether what is being called the COVID-19 vaccines even qualify as vaccines.¹⁶ She, particularly, investigates the idea of COVID-19 vaccines as self-replicating, targeting outcomes by genotype. She accuses Ralph Baric, Ph.D., the University of North Carolina Professor of Epidemiology who carried out the gain-of-function studies on a chimeric SARS-like virus with a spike protein that readily attached to human epithelial cells and replicated.¹⁷ Baric's research was so controversial because in 2013 all gain-of-function research was halted due to its potential for creating a global disaster.¹⁸ Both Baric and Peter Danszak at EcoHealth Alliance argued that such research was justified and necessary. Dr. Merritt says that Dr. Baric, in 2015, noticed that the spike protein on that gain-of-function paper, saw that the spike protein also damages salt reabsorption. As a "salt-wasting disease," she reminds her audience that giving afflicted people a quart of water with a teaspoon of salt and a teaspoon of baking soda right away when one begins to get sick, it can tremendously help people quickly. She says that Baric understood this in 2015, but failed to alert the public to this aspect of the spike protein. She accuses Baric and others who were doing this coronavirus, spike protein research that they just purposely let people die. She outlines a four-step process by which COVID-19 became a global pandemic: In Step One, the pathogen was created; in Step Two, the physical and psychological operation began with the release of the pathogen and the counting of cases rather than of sick people; Step Three was the rollout of what are really called "viral

based genetic therapies," the mRNA vaccines from Pfizer and Moderna. She says in an interview on American Media Periscope¹⁹ that the FDA warned these pharmaceutical companies that were testing mRNA technologies, that they had a "shedding" problem and that the toxic chemicals and nanoparticles were being transmitted to others who had not been injected with these materials. She cites an Australian research effort that reported these results.²⁰ She says that Stage Four is when we start to recognize the problems with what has already transpired. In the U.S. now, there is a 42% increase in the all-cause death rate.²¹ She says that the actuaries have calculated this uptick in all-cause mortality for the U.S. and other countries in the West.²² She says that this is a "13 Sigma" event in the U.S., Germany, U.K., and other countries. People are dying.²³ She mentions U.K. statistics from the Office for National Statistics²⁴ data that reveal a 13,000% increase in myocarditis among vaccinated young boys. On top of that, she reports the huge uptake in still births, miscarriages, sterility is just now taking off in the Western World. She cautions that it is The Western World that has this problem due to its higher vaccination rates; she states that the Russians and the Chinese did not vaccinate their militaries, whereas the Global West did. "We are now in a world that's facing a demographic shift," she says.²⁵ Dr. Merritt says that they are eliminating certain

populations without firing a shot. Further, these vaccines target the reproductive systems of women. She says that this outcome is similar to the outcome in an Australian experiment on "shedding" vaccines; she mentions the four HIV inserts found in the SARS-CoV-2 spike protein by the Indian scientists in early 2020.²⁶ These HIV insertsShe says that the mRNA produces trillions of the spike protein of SARS-CoV-2. If the spike protein is a bioweapon, then the vaccine is, too. In discussing the Johnson and Johnson vaccine, in particular, she cites an Australian paper that leads one to conclude that Suppose you can create a poison that doesn't make its creator sick. There are several papers that discuss the SARS-CoV-2 binding affinity by race and ethnicity. Conspiring to Commit Acts of Terror; Acts of Domestic Terrorism; Lying to Congress; Conspiring to Criminal Commercial Activity; Market Manipulation and Allocation; Interlocking Directorates; Illegal Clinical Trial, and more. was used in the Pfizer (and Moderna) COVID-19 vaccines. The so-called "Baby Boomer" generation of the U.S. were most resistant to taking the injection. word. These vaccines were developed by Pfizer and Moderna and had never been used by the mass public before. The path for them was "greased" by Presidential actions and an Emergency Use Authorization granted to the companies by the U.S. Federal Drug Administration. With a year of observation in hand, Stephanie Seneff and Greg Nigh delved into the health consequences of these vaccines. 

ALL-CAUSE EXCESS MORTALITY

Igor Chudov confirms that allcause excess mortality for young people in the U.S. is up. Chudov found this statistic to be "very disturbing and warranting further investigation." 38

Statistics Canada also reports higher excess mortality, across all age groups, but especially for young Canadian adults.³⁹ During the final twenty-five weeks of 2021, almost 900 more people died than were expected to die and the New Brunswick Health Minister held a press conference

to ask the Legislature to demand answers as to why this is happening. New Brunswick, British Columbia, Saskatchewan, and Alberta are also reporting higher than normal

excess mortality for the same period.⁴⁰ It is reported that a similar pattern holds for England, as well.⁴¹

ANAPHYLAXIS

Anaphylaxis, according to the U.K. National Health Service is "a severe and potentially life-threatening reaction to a trigger such as an allergy." The U.S. Centers for Disease Control and Prevention lists Anaphylaxis as a reported consequence of COVID-19 vaccination.⁴³

COVID-19

COVID-19, the disease, is actually an adverse health effect of the COVID-19 vaccines. Walgreens Pharmacy publishes its COVID-19 vaccination data⁴⁴ and finds that the triple-vaxxed test positive for COVID-19 at the highest rate while the unvaxxed test positive for COVID-19 at the lowest rate for the week of April 27, 2022 to May 3, 2022.⁴⁵ On his website, Dr. Paul Alexander discusses seven studies that help to explain why those who received the COVID-19 vaccination are getting more infections.⁴⁶ Dr. Alexander revealed that Pfizer offered him \$1 million and \$50,000 each month to, he thinks, close his

criticisms of the COVID-19 vaccines.⁴⁷ Further, Alliance for Natural Health unveiled that a global control group now study reveals that the unvaxxed rarely experience severe COVID-19.⁴⁸

DEATH

Between December 14, 2020 and June 6, 2022, the CDC admits to having received 14,980 reports of **Death** after COVID-19 vaccination.⁴⁹ However, the CDC has been found, by at least one longtime Vaccine Adverse Effects Reporting System (VAERS) database researcher, to be removing reports from its VAERS database. By comparing existing CDC VAERS website reported numbers to previous same-time reports on the internet's "wayback machine," data analyst Albert Benavides states, "500 death reports have already been deleted so far to date for COVID jabs. 10,000 claims have been deleted total since the rollout for COVID. I've spot-checked 2,000 of those claims and I cannot find the duplicate because, in the fine print, it says 'We delete duplicates and false reports."50 In the April 28, 2022 Stew Peters Network interview on which Epoch Times reports, Benavides noticed that more VAERS data was deleted for COVID-19 vaccines than for other vaccines. Benavides added, "'65 percent of all the COVID reports are classified as the lowest level: not serious . . . They don't even rise to the level of office visit, emergency, or in-patient hospital. But, when you read them, there's thousands of cardiac arrests, strokes, pulmonary embolisms . . . These are misclassified."51 Epoch Times then conducted its own comparisons. It reports:

"According to the latest VAERS data dated May 13, there were 1.268 million total COVID-19 claims in the database. There were 28,141 claims of death, 52, 299 reports of permanent disability, and 31, 437 instances of life-threatening events. An analysis by ABC News shows that 18.9 percent of COVID-19 deaths in August 2021

occurred among vaccinated Americans. In February 2022, this number had risen to more than 40 percent. In September 2021, only 1.1 percent of COVID-19 deaths were among U.S. citizens who had received two doses of the vaccine as well as a booster. Five months later, in February, the number surged to around 25 percent."⁵²

Children's Health Defense (CHD) reports, "Of the 13, 150 deaths reported as of May 27, 16% occurred within 24 hours of vaccination, 20% occurred with 48 hours of vaccination, and 59% occurred in people who experience an onset of symptoms within 48 hours of being vaccinated." The CHD also reports the following information about COVID-19 vaccination and deaths on its website:⁵³

U.S. VAERS data from Dec. 14, 2020, to May 27, 2022, for all age groups combined, show:

- 20% of deaths were related to cardiac disorders.
- 54% of those who died were male, 41% were female and the remaining death reports did not include the gender of the deceased.
- The average age of death was 73.
- As of May 27, 5,559 pregnant women reported adverse events related to COVID-19 vaccines, including 1.740 reports of miscarriage or premature birth.
- Of the 3,617 cases of Bells Palsy reported, 51% were attributed to Pfizer vaccinations, 40% to Moderna and 8% to J&I.
- 883 reports of Guillain-Barré syndrome, with 42% of cases attributed to Pfizer, 30% to Moderna and 28% to [8].
- 2,294 reports of anaphylaxis where the reaction was life-threatering, required treatment or resulted in death.
- 1,722 reports of myocardial infarction.
- 14,064 reports of blood-dotting disorders in the U.S. Of those, 6,294 reports were attributed to Pfizer, 5,032 reports to Moderna and 2,699 reports to J&I.
- 4,213 cases of myocarditis and pericarditis with 2,583 cases attributed to Pfizer's, 1,431 cases to Moderna's and 185 cases to J&J's CCVID-19 vaccines.

DISFIGURATION

Increased **Disfiguration** revealed by increased disability claims. So it's not just the number of unexplained deaths and adverse medical events from the vaccines, but it now appears that thousands of Americans are getting on disability following the introduction

of the COVID vaccines.⁵⁴ Meanwhile, almost 1.3 million reports are listed on the VAERS Database maintained by the U.S. CDC. Thus, 1,295,329 cases involving COVID-19 vaccines have been reported. This information comes from the June 3, 2022 release of VAERS data.⁵⁵

FALLING ATHLETES

From March 2021 to March 2022, the phenomenon of professional athletes collapsing on the field during a game became more pronounced. One America News Network (OAN) estimated that the number is almost 800, with the average age of the athletes suffering cardiac arrest is just pegged at 23 years of age. Another team of researchers put the figure at 890 cardiac arrests and other serious issues

among athletes including 579 deaths following the COVID-19 shots. Fifteen Miami Open players dropped out.⁵⁶ The OAN report continues:

attacks before now? And these are just the ones we know about. How many have gone unreported? Nearly 800 athletes — young, fit people in the prime of life —




falling down on the field. In fact, 500% more soccer players in the EU are dropping dead from heart attacks than just one year ago. Coincidence? When the Pfizer vaccine is known to cause heart inflammation? No. In fact, many doctors treating these players list their injuries and deaths as being directly caused by the vaccine . . . FETAL DEATHS

Operation Rescue is an anti-abortion organization in the U.S. Anne Reed, Senior Policy Advisor of Operation Rescue, investigated the instance of **Fetal Deaths** after COVID-19 vaccination of pregnant women, based on Pfizer's own documents, previously withheld from the public, whose release was forced due to court order. Pfizer's documents are



Other anti-abortion organizations, investigating the Vaccine Adverse Event Reporting System (VAERS) maintained by the U.S. Centers for Disease Control and Prevention (US CDC) find that a total of 283 adverse reports in VAERS where the symptom is spontaneous abortion or fetal death, as of May 22, 2021. Of these Abortion Free New Mexico finds that VAERS reports that 9.54% are attributed to J&J/Janssen; 36.75% is attributed to Moderna; and 53.71% of the spontaneous abortions reported on the VAERS system as of May 22, 2021 are

attributed to Pfizer BioNTech.⁵⁹ Abortion Free New Mexico found that most of these spontaneous abortions occurred within 30 days of vaccination. On May 31, 2022, Vaccine Impact newsletter warned that the "FDA had Data Showing 82% – 97% of Pregnant Women Injected with the Pfizer COVID-19 Vaccine Lost Their Babies Before Approving the Shots" and that the VAERS system shows 4,202 fetal deaths following COVID-19 vaccines, as of May 20, 2022.⁶⁰

GROUNDED PILOTS

U.S. Army Senior Flight Surgeon Lt. Col. Theresa Long testified before a U.S. Senate panel that believed that the COVID vaccine "is a greater threat to soldiers' health and military readiness than the virus itself." She went on to say, "in one morning I had to ground 3 out of 3 pilots due to vaccine injuries."⁶¹

Heart Inflammation: 3 June 2022 | Staff with the U.S. Food and Drug Administration (FDA) on Friday flagged the risk of heart inflammation following the administration of the Novavax COVID-19 vaccine, although they concluded the shot reduces the risk of mild-to-severe COVID-19. In the company's nearly 30,000 patient trial, conducted between December 2020 and September 2021, there were four cases of myocarditis, a type of heart inflammation also associated with mRNA vaccines, detected within 20 days post-vaccination... "These events raise the concern for a causal association with this vaccine, similar to the association documented with mRNA COVID19 vaccines," FDA staff wrote in briefing documents that were released on Friday.⁶² Listed under the subsection of the FDA report on Novavax entitled, Known and Potential Risks, Guillain-Barré is also listed for a single case arising within the 20-day post-vaccination period.⁶³

HEPATITIS

On April 21, a study that found a **hepatitis** effect from COVID-19 vaccination was published. Boettler, Csernalabics, et al conclude that COVID-19 vaccination can elicit inflammation in the liver leading to hepatitis.⁶⁴

LONG COVID, ALSO KNOWN AS VACCINE AIDS (VAIDS)

Long COVID also known as Vaccine AIDS (VAIDS) is a known consequence of the spike protein, present in both the COVID-19 disease and the COVID-19 mRNA vaccines. Speaking of the spike protein, one doctor told this author that what had been discovered was an aerosolized version AIDS. The U.S. CDC calls Long COVID alternatively "Post-COVID conditions. Obviously, since those who took the COVID vaccinations are more prone to subsequent COVID variant infections, the vaccinated become the group most susceptible to developing Long Covid. According to the CDC, the symptoms of Long COVID are shortness of breath, fatigue, brain fog, chest pain, headache, and other symptoms.

MONKEYPOX OR SHINGLES?

At least one 2021 study finds that it is possible that shingles is a side effect of COVID-19 vaccination.⁶⁶ The Exposé asks the question on everyone's radar: "Monkeypox: Lab Leak? Vaccine Injury? Or just a Coincidence?"⁶⁷ And then, we learn about a Monkeypox simulation that was run in March of 2021, after Dr. Fauci had begun funding monkeypox studies.

30 May 2022 | Anthony Fauci's National Institutes of Health agency was funding research to identify treatments for monkeypox shortly before the virus began spreading in a global outbreak. Fauci's agency, the National Institute of Allergy and Infectious Diseases (NIAID), has previously come under scrutiny for funding bat coronavirus research at the Wuhan Institute of Virology, which many public health experts and intelligence officials believe to be the source of COVID-19. **NIAID has also funded research into potential cures for monkeypox, shortly before the viral disease began spreading in a global outbreak** The grant supports a "randomized, placebo-controlled trial of the safety and efficacy of tecovirimat for the treatment of patients with monkeypox virus disease." "The funding supports a clinical trial to identify effective treatments for monkeypox virus disease," explains a summary of the research, which, **despite beginning in September 2020, has not generated any publicly available studies, papers, or patents.** 68

NEW-ONSET KIDNEY DISEASE

By February 2022, another COVID-19 vaccine side-effect was becoming known: **New-Onset Kidney Disease**. Biopsies were revealing several pathologies: "(1) IgA nephropathy presenting with painless gross hematuria, (2) minimal change disease presenting with nephrotic syndrome, (3) thrombotic microangiopathy, and (4) acute tubulointerstitial nephritis presenting with acute kidney injury." Lim, Kim, et al conclude, "This case series provides information on new-onset renal histopathology after

COVID-19 vaccination. The need for COVID-19 vaccination, including booster shots, is being emphasized globally. Although we could not confirm causality between vaccinations and these phenomena, in this time of mass vaccination, clinicians need to consider the possibility that vaccines may have provoked kidney diseases in patients who have renal symptoms."

POLYETHYLENE GLYCOL IN BREAST MILK OF NURSING MOTHERS

Polyethylene Glycol (PEG) in Breast Milk Naomi Wolf "They [the NIH] found polyethylene glycol in trace amounts in vaccinated women's breast milk. They decided it was negligible. How much of a petroleum product is negligible when you're a tiny newborn with no immunities, and this is your only food? And the study acknowledged that the vaccinated mothers' babies are having agitation and sleeplessness and gastrointestinal issues."

PREMATURE DEATHS

Premature Deaths. 92% of the deaths in England have been in the triple-vaccinated. 52 times higher risk in deaths in kids from 10 to 14, and the data's pretty — thank God for the National Health Service data that's actually been helpful. Our CDC has been a complete, fabricated bunch of lies ..." Dr. Richard Urso, June 6, 2022 World Council for Health General Assembly Meeting.

PRION DISEASE (ALZHEIMER'S, LOU GEHRIG'S DISEASE, ALS)

Prion Disease (Alzheimer's and Lou Gehrig's Disease, ALS) are suspected side effects of the COVID-19 vaccines. The news report below tells the story, however, please see the section that comes later in this paper entitled FAKE NEWS for a fuller appreciation of the trajectory of scientific inquiry deemed heresy, pushback from all sides, including and especially in the media, and then scientific confirmation of the initial heretical thought. The case that presented in this specific example is about prion disease, especially coming after the death of a prominent scientist from prion disease who was working on a COVID-19 vaccine.

"Several studies on COVID-19 vaccines have suggested a link between the vaccines and Creutzfeldt-Jakob disease (CJD), a rare and fatal brain condition. A preprint French study suggests that the Pfizer, Moderna, and AstraZeneca vaccines may have contributed to the emergence of a new type of sporadic CJD that is much more aggressive and rapid in progression than the traditional form of the disease.

CJD is caused by abnormalities in a protein in the brain called a prion. The naturally occurring proteins are usually harmless, but when they become diseased or misfolded, they cause nearby prions to also become misshapen, leading to the deterioration of brain tissue and eventually death. The disease is incurable, as once one prion becomes infected, it continues to propagate to other prions, and currently there isn't any treatment capable of stopping its progress. The majority of people with CJD have the sporadic type, meaning they become infected for no apparent reason. A small subset of people are diagnosed due to heredity. Sporadic CJD, though occurring at random, has been linked to the consumption of contaminated meat, such as beef from a cow that has been infected with diseased prions.

Though the Omicron variant of COVID-19 doesn't carry a prion region in its spike protein, the original Wuhan COVID-19 variant had one. Therefore, when the Wuhan variant's spike protein gene information was made into a vaccine as part of mRNA and adenoviral DNA vaccines, the prion region was also incorporated. A U.S. study published in the journal Microorganisms indicated that the prion area is able to interact with human cells. After a patient takes an mRNA vaccine from Pfizer or Moderna, the mRNA is naturally incorporated into the person's cells, which then use the mRNA instructions to produce a synthetic spike protein. This tricks the cells into believing that they have been infected so that they create an immunological memory against a component of the coronavirus. For the AstraZeneca vaccine, which uses an adenoviral vector platform, the DNA of the spike protein is carried into the cell through an adenoviral vector and then into the nucleus, where all human DNA is stored. From there, the DNA is transcribed into mRNA and made into the spike protein. Though major health organizations say genetic material from the vaccines isn't incorporated into human DNA, mRNA studies conducted on human cells in labs have found that mRNA can be transcribed into DNA and then incorporated into the human genome. Unfortunately, the biological process of translating mRNA information into proteins isn't perfect nor immune to mistakes, and protein misfolding can occur.

Another U.S. study, published in the International Journal of Vaccine Theory, Practice, and Research, speculated that a misfolded spike protein could, in turn, create a misfolded prion region that may be able to interact with healthy prions to cause damage, leading to CJD disease. Previous studies of CJD in cannibalistic

groups have indicated that CJD can remain dormant after infection for around 10 years or more. However, the authors of the French study found that the CJD cases observed in individuals who had received COVID-19 vaccines were a lot more rapid in onset, with symptoms appearing within 11.38 days of being vaccinated. A peer-reviewed study in Turkey (pdf) identified a sudden case of CJD in an 82-year-old woman whose symptoms appeared one day after receiving the first dose of the Sinovac COVID-19 vaccine, also known as CoronaVac. Unlike mRNA- and vector-based vaccines, CoronaVac is an inactivated vaccine, which means that it contains an inactivated version of the original coronavirus. The French study identified 26 cases across Europe and the United States. Twenty of the individuals had already died by the time the study was written, with death occurring, on average, 4.76 months after being vaccinated. "This confirms the radically different nature of this new form of CJD, whereas the classic form requires several decades," the researchers wrote.

The study's lead author, Dr. Jean-Claude Perez, informed The Epoch Times on June 6 by email that all 26 patients had died."⁷⁰

SUDDEN ADULT DEATH SYNDROME

Sudden Adult Death Syndrome (SADS) was first diagnosed in 1977 when adults died unexpectedly and postmortem, no obvious cause of death could be found.⁷¹ An example follows, since only conspiracy theorists would believe that the COVID-19 vaccinations had anything to do with the deaths:

"Within days of receiving their first shot of the COVID-19 vaccination, nearly two dozen nursing home residents in Norway died, prompting a health warning for elderly patients above 80 years old. The Norwegian Medicines Authority (NMA) announced the deaths of 23 patients who had been given the Pfizer/BioNTech vaccine for coronavirus on Friday. Thirteen of those victims have undergone

postmortem examination, with findings indicating that common adverse effects from the vaccine were to blame for the staggering mortality rate. The Norwegian Medicines Agency's chief physician, Sigurd Hortemo, said that the vaccine's typical side effects, such as nausea and fever, 'may have exacerbated the condition in some elderly patients.' Following the deaths, Norway's health authorities urged that the vaccine be avoided by those with severe underlying diseases who are above 80 because of concerns over its safety."⁷²

THROMBOSIS WITH THROMBOCYTOPENIA SYNDROME (TTS)

Thrombosis with Thrombocytopenia Syndrome (TTS) is specifically mentioned by the U.S. Centers for Disease Control and Prevention as a rare result of the Johnson & Johnson/Janssen COVIDF-19 vaccine,⁷³ however blood clots have been produced by more than just the J&J/Janssen vaccine.


